§ 1.

Pursuant to § 12 section 2 of resolution no. 64/14 of the Senate of the University of Gdańsk of September 25, 2014, regarding the guidelines for fees for university courses of study and other educational services rendered by the University of Gdańsk and the procedures and conditions of waiving them, in accordance with the current ordinance of the Rector concerning fees for educational services provided at the University of Gdańsk, the following changes are introduced to the agreement mentioned in the introduction to this document\*\*:

1) in § 5 section 1 of the agreement regarding conditions for payment for studies and educational services at the University of Gdańsk (model agreement – annex no. 1 to resolution no. 72/11 of the Senate of the University of Gdańsk of September 29, 2011, regarding conditions for payment for university courses of study and educational services rendered by the University of Gdańsk and the procedures and conditions for waiving such payments), a second sentence is added as follows: “For repeating a subject that a student has permission to take in the next grading period (with an ECTS point deficit) the student agrees to pay a fee equal to the number of ECTS points for the subject that has not been passed multiplied by the cost per ECTS

point of 100 PLN (the total payment for repeating subjects that a student has permission to take can not exceed 1200 PLN)”;

2) in § 5 section 1 of the agreement regarding payment for educational services at the University of Gdańsk rendered to students on full-time day studies (model agreement – annex no. 1 to resolution no. 51/13 of the Senate of the University of Gdańsk of July 9, 2013, regarding the principles for collecting payments for studies and educational services rendered by the University of Gdańsk and the procedures and conditions for waiving such payments):

a) point 1 is deleted,

b) point 2 is deleted,

c) a point 6a is added as follows: “6a) fee for repeating a subject that a student has permission to take in the next grading period (with a ECTS point deficit) at a level equal to the number of ECTS points for the subject that has not been passed multiplied by the cost per ECTS point as set by ordinance of the Rector (the total payment for repeating subjects that a student has permission to take can not exceed 1200 PLN)”;

3) in § 5 section 1 of the agreement regarding conditions for payment of fees for educational services at the University of Gdańsk rendered to extramural students (model agreement – annex no. 2 to resolution no. 51/13 of the Senate of the University of Gdańsk of July 9, 2013, regarding the principles for collecting payments for studies and educational services rendered by the University of Gdańsk and the procedures and conditions for waiving such payments), point 5a is added as follows: “5a) fee for repeating a subject that a student has permission to take in the next grading period (with a ECTS point deficit) at a level equal to the number of ECTS points for the subject that has not been passed multiplied by the cost per ECTS point as set by ordinance of the Rector (the total payment for repeating subjects that a student has permission to take can not exceed 1200 PLN)”;

4) in § 5 section 1 of the agreement regarding conditions for payment of fees for educational services at the University of Gdańsk rendered to extramural students of the Faculty of Economics (model agreement – annex no. 3 to resolution no. 51/13 of the Senate of the University of Gdańsk of July 9, 2013, regarding the principles for collecting payments for studies and educational services rendered by the University of Gdańsk and the procedures and conditions for waiving such payments), a point 5a is added as follows: “5a) fee for repeating a subject that a student has permission to take in the next grading period (with a ECTS point deficit) at a level equal to the number of ECTS points for the subject that has not been passed multiplied by the cost per ECTS point as set by ordinance of the Rector (the total payment for repeating subjects that a student has permission to take can not exceed 1200 PLN)”.

The remaining provisions are unchanged.
